IAF 32ND WORLD FASHION CONVENTION



The IAF 32nd World Fashion Convention took place at the end of September this year in Mumbai, India. More than 250 attendees (industry and association representatives) from 20 countries were attending the convention. CMAI was the co-host of this event this year.

As IAF is a worldwide network platform for apparel industry, GINETEX met with different major national entities from Turkey, Bangladesh, India, South Africa, Iran, etc ...

After the IAF General Assembly this year, the IAF Executive committee and board have elected their new President, Mr Han BEKKE from Modint who succeeds to Rahul Mehta from CMAI.

Next year, the IAF World Fashion Convention will be hosted by ABIT, textile and garment industry association, our GINETEX Brazilian National Member. It will take place in Rio de Janeiro from October 16 – 18, 2017. Apart from a beautiful location, Brazil has one of the largest apparel and textile manufacturing industries in the world.



JAPAN LEGAL UPDATE



Since December 1st, 2016, **GINETEX** care labelling symbols can be used on textile product labels in Japan.

But what are the consequences for garment producers in relation to the planned changes in the care labelling system in Japan scheduled for 1st of December 2016?

- Textile articles showing exclusively the care label symbols according to ISO 3758 can be used on the Japanese market only after 1st of December.
- Textile articles showing exclusively the “old” care labels, being manufactured before 1st of December can still be sold on the Japanese market.
- Textile articles showing exclusively the “old” care label, being manufactured after 1st of December may not be placed on the Japanese market.



As a reminder, Kaken has been selected by **GINETEX** as national member in Japan in charge of the promotion and the coordination of the use of its textile care labelling symbols under ISO standard system.

BREXIT EFFECTS



GINETEX confirms that Brexit should have no legal effects on textile care labelling. GINETEX textile care labelling symbols under ISO 3758 standard are still recommended in the UK and no particular changes are expected in regards to the content and policy of the textile care labels.



CARE LABELLING LEGAL REQUIREMENTS FOR IRAN – ISO 3758



As of the beginning of 2016, Iran offers large opportunities to foreign apparel companies with the opening of its commercial frontiers; In this regard, GINETEX would like to highlight the legal requirements in terms of textile care labelling when selling products in this country.

In terms of textile care labelling, the ISO 3758:2012 is the standard in Iran which allows garment companies to use the GINETEX symbols. The International Association already deposited its 5 symbol trademark.

However, other requirements are important to take into account. Foreign garment companies must work and import their textile products through a local importer which must have a specific license to do so.

Compulsory information on labels are the following: care instructions, manufacturing country, size information and composition details.

Iran is not yet a member of OMC. We still lack feedback of experience in this country as commercial exchanges are pretty new. However any remarks or comments

from the authorities will go through the local importer who takes all the responsibility in regards to the product entrance into the country.

Product labelling doesn't seem to be a difficulty at the moment. However, with an increasing volume of textile products entering the country there might be an increasing risk that products could be held back at customs if they are not labelled correctly.

GINETEX HOSTS ITS GENERAL ASSEMBLY 2016 IN BRNO, CZECH REPUBLIC ON OCTOBER 25TH.

On Tuesday, October 25th, 30 representatives of GINETEX National Committees attended the General Assembly in Brno, in Czech Republic.

This year, General Assembly marks the end of another official two years' period of Presidency of GINETEX with the first Presidency of Germany. The year of 2016 was an excellent year for the International Association. Four new national committees – Japan, Norway, Slovakia and Spain – joined GINETEX. At the end of the General Assembly, Mr. Adam Mansell, Chief Executive Officer of the UK Fashion & Textile Association (UKFT) succeeded to Mr. Thomas Rasch. Adam Mansell was nominated unanimously President of GINETEX by the General Assembly of GINETEX, for a two year term of office for the period 2016 – 2018.

Adam Mansell joined the textile and clothing industry 20 years ago, beginning as an Executive at the British Clothing Industry Association and going on to work for a number of trade bodies including the British Interior Textile Association, Silk Association of Great Britain, Home Laundering Consultative Council and British Apparel & Textile Confederation. Having represented all aspects of the fashion and textile supply chain, Adam has links to every part of the industry from design, fabric and component suppliers, wholesalers, brands,

They are now deposited and registered in a high number of countries worldwide.
